

Terms & Conditions: Bank Gaborone Swipe & Win

These competition rules (“rules”) explain Your rights and duties under this competition. If You take part in this competition or accept any prize, these rules will apply to You, and You agree that the person running the competition (“the promoter/s”) will assume that You have read and agree to be legally bound by these rules. Please ensure you read these rules carefully.

1. The Swipe and Win Competition (the “Competition”) is open to all Bank Gaborone Visa credit and debit cardholders aged 18 years and above, who hold a transactional account with the Bank.
2. The Competition will run over a three-month period commencing on 07th June 2024 to 30th August 2024.
3. Customers who swipe or tap their Bank Gaborone Visa debit or credit card on any Bank swiping machine shall, subject to clause 1 above, be automatically entered into the Competition and shall stand a chance to win a share of P300,000; weekly cash prize of BWP5,000.00 and Grand Prize of BWP60,000.00 at the end of the competition.
4. There are no restrictions on the number of valid and successful swipe and tap entries per Customer.
5. Participation in this Competition is free with no participant Competition costs, except amounts swiped or tapped as per clause 1 and 4, and any associated bank charges in the normal course of business.
6. Every Monday, the swipe & win team, a Business analyst and an internal auditor will extract data for the week and use the Excel Randomizer Function to select a winner. The function will be ran 4 times to randomly pick the 4 weekly winners.
7. The same process will be followed during the grand prize draw. The function will run once to randomly pick 1 grand prize winner.
8. The weekly draws will be held at Bank Gaborone Head Office in the mornings at 1000hrs, every Monday of the 12 weeks beginning 14th June 2024. The draws will not be open to the public.
9. The Grand Prize draw will be held at Bank Gaborone Head Office on Saturday the 07th September 2024 at 1000hrs. The draw will be open to the public.
10. Potential winners will be contacted telephonically, via the telephone or mobile number registered with the Bank and announced on social media and radio. The winner will be contacted for a period of 3 months using all means necessary (telephone, mail & visit to their physical address), should the Bank still fail to contact them after the 3 months, the winner forfeits the prize. The selection process of each winner shall be overseen by Bank Gaborone internal auditors.
11. The date, time, and venue of the weekly activations will be publicly communicated via applicable media including SMS, radio & social media.
12. Winners must produce valid original identification documents in the form of either their OMANG (citizens) or Passport (non—citizens), when claiming their prize.
13. Prizes won cannot be exchanged and/or returned and neither are they negotiable nor transferable.
14. The Bank shall, upon approval from Gambling Authority, conduct a re—draw should it, for any reason whatsoever, and after all available means to contact the initial winner have been exhausted. In such circumstances, the entrants and/or initial winner for the weekly & grand prize at the time, shall irrevocably waive their rights to the prize money;
