

## Itirele Bokamoso Competition Ts & Cs

These competition rules (“rules”) explain Your rights and duties under this competition. If You take part in this competition or accept any prize, these rules will apply to You and You agree that the person running the competition (“the promoter/s”) can assume that You have read and agree to be legally bound by these rules. Please ensure you read these rules carefully.

1. The ‘Itirele Bokamoso’ Competition (the “Competition”) is open to all Botswana Teachers’ Union (BTU) Scheme members aged 18 years and above, who apply for any loan of up to P750,000.00 with Bank Gaborone (the Bank) during the competition period. Entry is valid only when the loan is approved and credited during the competition period.
2. The Competition will run for a three (3) months period commencing at 0000hrs on 02<sup>nd</sup> September to 1159hrs on 30<sup>th</sup> November 2024.
3. BTU scheme members who apply & get a loan of up to P750,000.00, subject to clause 1 above, shall be automatically entered into the Competition and shall stand a chance to be one (1) of the ten (10) winners who will win P10,000.00 cash each week. One (1) customer will also stand a chance to win a grand prize of P50,000.00 at the end of the competition.
4. There are no restrictions on the number of loans a client may apply for to qualify for entry into the competition.
5. There are no charges paid to participate in this competition.
6. Any associated bank charges in the normal course of business will apply.
7. Every Friday, a BTU representative and the Bank Gaborone team inclusive of a Business analyst and an internal auditor will extract data for the week and use the Excel Randomizer Function to select a winner.
8. The same process will be followed during the grand prize draw. The function will run once to randomly pick 1 grand prize winner.
9. The weekly draws will be held at Bank Gaborone Head Office in the mornings at 1000hrs, every Monday of the 12 weeks beginning 09<sup>th</sup> September 2024. The draws will not be open to the public.
10. The grand prize draw will be held at the Bank Gaborone Head Office on 07<sup>th</sup> December 2024. It will be attended by Bank Gaborone staff, BTU members and media.
11. Potential winners will be contacted telephonically, via the telephone or mobile number registered with the Bank and announced on social media and radio. The winner will be contacted for a period of 3 months using all means necessary (telephone, mail & visit to their physical address), should the Bank still fail to contact them after the 3 months, the winner forfeits the prize.
12. The Bank shall, upon approval from Gambling Authority, conduct a re—draw should it, for any reason whatsoever, and after all available means to contact the initial winner have been exhausted. In such circumstances, the entrants and/or initial winner for the weekly & grand prize at the time, shall irrevocably waive their rights to the prize money;
13. The date, time, and venue of the grand prize draw will be publicly communicated via applicable media including SMS & social media channels prior to the draw.
14. Winners must produce valid original identification documents in the form of either their OMANG (citizens) or Passport (non—citizens), when claiming their prize.

20. This Competition is not open to BANK GABORONE Staff, BANK GABORONE Directors, Suppliers and/or the immediate family members of the aforementioned class of persons.
